- STATE INSPECTION REPORTS: If the proposed event involves amusement rides, the operator or sponsor shall attach copies of the current inspection reports or permits as required by Chapter 88A of the Iowa Code.
- USE OF TENTS: If the proposed event involves the erection of a tent for the use of the public, no such tent may be used until inspected by officials of the Fire Prevention Bureau of the City of Sioux City.
- LETTER OF PERMISSION from the property owner is required to be filed with the application.
- INSURANCE: The minimum requirements are as follows and a copy of your insurance policy must be filed along with this application.
