1. PROJECT PROGRESS

The City of Sioux City (City) is working with HR Green, Inc. (HR Green) to accomplish activities outlined in the Cooperative Agreement Work Plan. Specific tasks are outlined below.

1.1 Status of Activities During the Reporting Period

Workplan Task 1: Program Implementation:

• Submit Quarterly Progress Reports (QPRs): The City completed QPR #4 covering activities conducted during Quarter 4 of Federal Fiscal Year 2022.

Workplan Task 2: Community Outreach:

Site-specific Outputs/ Deliverables:

- Create a Project Website: The City updated its project website (<u>www.sioux-city.org/brownfields</u>) to include past QPRs and an executive summary for each Phase I ESA completed under the cooperative agreement. The City also produced English and Spanish versions of a business card to help promote its brownfields project website.
- Host a Community Outreach Meeting: The City reserved a table at the "Faces of Siouxland Multicultural Fair" celebration on September 18, 2022 to present information on the community's participation in the EPA Brownfields Program. City staff disseminated its brownfields brochure to citizens, as well as a business

card promoting Sioux City's brownfields website. All documents were available in English and Spanish.



Workplan Task 3: Environmental Site Assessments:

Site-specific Outputs/ Deliverables:

- Prepare a Quality Assurance Project Plan
 - The City submitted its Quality Assurance Project Plan to EPA on August 29, 2022. The document outlines the City's methods for conducting sampling activities. It places specific emphasis on ensuring the quality of field sample and measurements data collection, sample analysis and subsequent data validation, and evaluation and reporting. EPA is reviewing the document.

Conduct Phase I ESAs:

- The City completed a Phase I ESA on the 14.4-acre Boys and Girls Home located at 2101 Court Street. The report identified several on-and-offsite RECs.
- The City completed a Phase I ESA on a 0.17-acre vacant mixed-use building located at 615 Douglas Street. The report identified several onand-off-site RECs.
- The City completed a Phase I ESA on a 0.34-acre community theater located at 625 Douglas Street. The report identified several on-and-offsite RECs.

Conduct Phase II ESAs:

- The City submitted a Phase II Sampling Plan to EPA for a 0.77-acre surface parking lot located at 3717 Summit Street. EPA is reviewing the document.
- The City began working on a Phase II Sampling Plan for a 0.34-acre community theater located at 625 Douglas Street. The City will submit the document during Quarter 1 of Federal Fiscal Year 2023.
- The City began working on a Phase II Sampling Plan for a 0.17-acre vacant mixed-use building located at 615 Douglas Street. The City will submit

- the document during Quarter 1 of Federal Fiscal Year 2023.
- The City began working on a Phase II Sampling Plans for two adjoining vacant former industrial operations totaling 1.39 acres at 901 and 919 5th Street. The City will submit the document during Quarter 1 of Federal Fiscal Year 2023.
- The City submitted an application for EPA Targeted Brownfields
 Assistance (TBA) to complete a Phase II Environmental Site Assessment,
 an Analysis of Brownfields Cleanup Alternatives (ABCA) report, and a
 Hazardous Material Survey (includes lead-based paint, asbestos, and PCB
 assessment) on the 14.4-acre Boys and Girls Home located at 2101 Court
 Street.
