# **CALL OF THE ROLL**

#### **APPROVAL OF MINUTES**

### **DISCUSSION**

**Air Service:** Staff recently had a call with the DOT regarding EAS service. Planning for a March/April time frame regarding the Part-135 certification. On March 3, 2023, the schedule shows the tag flight to North Platte will be removed allowing for a direct flight to Denver again. **Construction Projects Update**: There are punch list items remaining from the Runway 13-31 Rehab Project that carried over from last summer. There are potentially five construction projects coming soon in the spring. The terminal roof and 2 hvac unit replacements will also be completed

in the spring. **SkyWest Airlines:** unavailable due to working of the flight.

Hawthorne: Expressed they were happy regarding the potential sealcoat project in their area.

**Oracle:** Next month we should start seeing the walls going up on the new facility. Morningside University hired a Chief Flight Instructor, Aaron Diedrichs. Once he gets on board, they will be working towards their Part 141 certification. They've had 25 potential students visit campus regarding the program already. Larger schools are unable to get students in the air during their first year due to flight instructor demand.

**ABM:** Winter weather has created some issues and our gate open for a period of time. Staff asked about weather stripping or weather shields. They plan to replace heaters due to frost on the barcode readers.

<u>FINANCIAL REPORT</u>- We are pretty much equal to where we were a year ago. The only difference is in the expense with the watermain break of \$50,000. Recently provided more detail to the City Council at their wrap up session regarding the projects planned for the next five years.

The draft vision statement was displayed, and staff plans to bring before the Board to adopt in March.

<u>MARKETING</u>- Operations were up 4% for the month. Enplanements were down 14%. Denver load factors are at 59%, Chicago held strong at 76%. Future booking has DEN at 36% and ORD at 70%. The Siouxland Chamber hosted their transportation meeting at the Airport on February 9<sup>th</sup> and they had a good turnout. It was great to see over 30 in attendance learning from our air industry partners including Gary Foss from ArkStar, and Daniel Belmont from SkyWest, and Dave

Poole, from Oracle Aviation. May is the Washington, DC trip and they are considering a paper on pilot shortage and the essential air service market.
