ONGOING MONITORING

Passing the Inspection is not a statement that the Property is free of LBP. The Inspection is limited to the scope of work proposed by the project bid specifications. Please refer to the original LBP Inspection/Risk Assessment previously completed for a list of identified components containing LBP. As stated in the previously completed report, the following ongoing monitoring should be implemented for the Property.

During the initial LBP Inspection/Risk Assessment, LBP and/or lead hazards were positively identified in the Property. However, some areas were identified as in intact condition, which may prevent them from being a hazard. Those areas of the Property containing LBP that were not included in the project specifications, or those that received interim controls should be incorporated into the ongoing monitoring plan.

Ongoing monitoring will be necessary at the Property since LBP is present. When LBP is present, the potential exists for LBP hazards to develop. Hazards can develop by several causes including. but not limited to the following: the failure of lead hazard control methods; previously intact LBP becoming deteriorated; dangerous levels of in-dust (dust lead) re-accumulating through friction, impact and deterioration of paint; or, through the introduction of contaminated exterior dust and soil into the interior of the structure. Ongoing monitoring typically includes two different activities: re-evaluation and annual visual assessments. A re-evaluation is a risk assessment that includes limited soil and dust sampling and a visual evaluation of paint films and any existing lead hazard controls. Re-evaluations are supplemented with visual assessments by the Property owner, which should be conducted at least once a year, when the property owner or its management agent (if housing is rented in the future) receives complaints from residents about deteriorated paint or other potential lead hazards, when the residence (or if, in the future, the house will have more than one dwelling unit, any that turn over or becomes vacant), or when significant damage occurs that could affect the integrity of hazard control treatments (e.g. flooding, vandalism, fire). The visual assessment should cover the dwelling unit (if, in the future, the housing will have more than one dwelling unit, each unit and each common area used by resident) exterior painted surfaces, and ground cover (if control of soil-lead hazards is required or recommended). Visual assessments should confirm that all paint known LBP is not deteriorating, that lead hazard control methods have not failed, and that structural problems do not threaten the integrity of any remaining known or suspected LBP.

It should be noted that lead concentrations (in paint) that are less than the levels that identify a surface coating as LBP still have the potential of causing lead poisoning. Should these or any potential LBP painted component and/or surface be disturbed in any manner that generates dust, extreme care must be taken to limit its spread. Remember that any renovation or remodeling work can disturb paint, which is currently not a hazard, and result in creating a hazard. Safe work practices should always be used during any remodeling project, in addition to using a certified lead abatement contractor or professional certified lead worker. As long as there is lead-based paint present in the home, there is a potential for lead hazards.

Visual assessments do not replace the need for professional re-evaluation by a certified risk assessor. The professional re-evaluation should include:

- 1. A review of prior reports to determine where lead-based paint and lead-based paint hazards have been found, what controls were done, and when these findings and controls happened;
- 2. A visual assessment to identify deteriorated paint, failures of previous hazard controls, visible dust and debris, and bare soil;
- 3. Environmental testing for lead in dust, newly deteriorated paint, and newly bare soil; and
- 4. A report describing the findings of the re-evaluation, including the location of any lead based paint hazards, the location of any failures of previous hazard controls, and as needed, acceptable options for the control of hazards, the repair of previous controls, and modification of monitoring and maintenance practices.

The first re-evaluation should be conducted no later than two years after completion of hazard controls, or, if specific controls or treatment are not conducted, two years from the beginning of ongoing lead-based paint monitoring and maintenance activities. Subsequent re-evaluations should be conducted at intervals of two years, plus or minus 60 days. If two consecutive reevaluations are conducted two years apart without finding a lead-based paint hazard, reevaluations may be discontinued.

Please refer to your community development agency, housing authority, or other applicable agency for additional local/regional regulations and guidelines governing re-evaluation activities.

CONDITIONS & LIMITATIONS

A copy of the complete clearance report must be provided to all lessees (tenants) and/or to purchasers of the property under Federal Law (Section 1018 of Title X – found in 24 CFR part 35 and 40 CFR part 745) and State Law (IAC 641 Chapter 70) before they become obligated under a lease or sales contract transaction, or the demolition of this Property. Landlords (Lessors) and/or sellers are also required to distribute an educational pamphlet developed by the Iowa Department of Public Health (IDPH) entitled "Lead Poisoning: How To Protect Iowa Families" and include standard warning language in their leases or sales contracts to ensure that parents have the information they need to protect their children from lead-based paint hazards.

lowa Law (IAC 641 Chapter 69 – Renovation, Remodeling, and Repainting – Lead Hazard Notification Process) requires contractors and landlords conducting renovation, remodeling, or repainting activities on a residential property or child occupied facility built prior to 1978 must notify occupants that hazardous lead-based paint may be disturbed. The contractor or landlord must also provide the pamphlet, *Lead Poisoning: How To Protect Iowa Families*, or the federal pamphlet, *Renovate Right*, to the owner and adult occupants of each dwelling unit where renovation, remodeling, or repainting will be performed.
