#### **2.46.010 Board Created.**

---

There is hereby created a nine-member board for the purpose of advising the city council on environmental issues in Sioux City and the Siouxland area consistent with the terms and provisions of this chapter, to be known as the Sioux City Environmental Advisory Board.

#### **2.46.020 Appointment and Qualifications.**

---

The board shall be appointed by a majority vote of the city council. To be eligible to be appointed a member of the board, five appointees must be residents of Sioux City, Iowa, and the remaining four positions shall be filled by residents of Sioux City, Iowa, owners of property within Sioux City, Iowa, owners of a business within Sioux City, Iowa, or an employee of a business within Sioux City, Iowa who resides either inside or outside the city limits. Before assuming the duties of the office, each board member shall file with the city clerk an oath for the faithful performance of the member's duties, and a disclosure of the member's ownership or control or prior ownership or control within the preceding two years of any interest, direct or indirect, in any property included or planned to be included in an urban renewal project. Notwithstanding the foregoing, upon adoption of this ordinance, current members of the board shall continue in their position until expiration of their terms. Upon expiration of their terms the new provisions shall apply to future members.

## **2.46.040 Organization of the Board.**

---

As soon as possible after the appointment of the initial members, the board shall organize for the transaction of business; elect a chair from its members who are residents of Sioux City; appoint a secretary; and adopt by-laws and regulations to govern the proceedings of the board. Five members of the board shall constitute a quorum for the transaction of business. All actions of the board shall be either by resolution or motion and the affirmative vote of a majority of the quorum shall be necessary for the passage of either action.

## **2.46.050 Meetings and Minutes.**

---

The board shall hold at least six public meetings during each calendar year. Minutes of each meeting shall be kept and all resolutions and minutes shall be open to public inspection. The board shall comply with the open meetings law of the State of Iowa.

## **2.46.060 Powers of the Board.**

---

1. The board shall have the following duties:
  - a. To make recommendations on a plan to enable Sioux City to meet State mandated reductions in solid waste.
  - b. To make recommendations on an integrated solid waste management plan.
  - c. To make recommendations on rates for environmental projects as requested by the council or city manager.
  - d. To recommend a program for educating the community on environmental education issues.
  - e. To make recommendations on environmental planning issues as requested by the council or city manager.
  - f. To make recommendations regarding the development of the storm water pollution prevention program as it applies to the citizen involvement and community education programs.
2. Voting powers.
  - a. All members shall have the right to vote.

## **2.46.070 Responsibilities of the Board.**

---

It shall be the responsibility of the board to file with the city clerk for public inspection copies of minutes of all board meetings and resolutions duly passed by the board within fourteen days of the meeting at which such action was taken.

#### **2.46.080 Removal of Board Members.**

Board members may be removed by a majority vote of the city council for good case shown as determined by the city council of the city.
